## **HeinOnline Libraries**

Hein distributes its content through collections or "libraries." Institutions subscribe to Hein's defined "core collection" of libraries and select additional relevant "a-la-carte" libraries that suit the needs of their community. The a-la-carte libraries include unique thematic digital content, such as world constitutions or moot court documentation. The summaries are based on information from Hein; <u>up-to-date information</u> on the extent of volumes and pages in each library may be found on Hein's website.

**European Center for Minority Issues** The ECMI conducts practice-oriented research, provides information and documentation, and offers advisory services concerning minority-majority relations in Europe. This library contains several publications of the ECMI, including ECMI Reports and Working Papers. Titles: 5

**Federal Register (FR) Library** The *FR* is the official journal of the activities and decisions of the federal government of the United States. It is produced daily (except holidays) and is compiled as public domain material by the Office of the Federal Register (within the National Archives and Records Administration)

and printed by the Government Printing Office. Hein's *FR* coverage is comprehensive and begins from its inception (1936). The library also includes The Code of Federal Regulations (CFR), which is the codification of the general and permanent rules and regulations (sometimes called administrative law) published in the *Federal Register* by the executive departments and agencies of the federal government of the United States from inception (1938). Also included is *The United States Government Manual*, which, since 1939, has provided comprehensive information on the agencies of the legislative, judicial, and executive branches, and a daily and weekly compilation of presidential documents since 1965. Law Journal Library Currently Hein hosts virtually all U.S. law reviews from their inception to the present, and it also provides access to dozens of Australian, Canadian, and other non-U.S. journals. It contains approximately 1,530 law and law-related periodicals. Hein purports to have the most comprehensive online full-text coverage of law review articles—and is the only online source for older articles. It provides coverage of all periodicals from the first published issue through the most current issue available to Hein through contracts with publishers. (The current issues of many law reviews are not available to Hein.) Users may search by title, author, subject, state, or country published, full text, and date. There are some functional problems, including that key word searching of full text of articles can lead to overwhelming results. Hein is working on improving their search engine to include the ability to search individual journals.<sup>1</sup>

## A-La-Carte Libraries

American Law Institute Library (ALI) ALI is a 501(c)(3) nonprofit organization incorporated in the District of Columbia. It produces scholarly work to clarify, modernize, and otherwise improve the law. The institute (made up of 4000 lawyers, judges, and law professors) drafts, discusses, revises, and publishes Restatements of the Law, model statutes, and principles of law that influence both U.S. and international courts and legislatures, as well as legal scholarship and education. The library contains the full runs of the American Law Institute's annual reports, proceedings, annual meeting speeches, and the institute's newsletter, The ALI Reporter. It also includes the *Restatements of the Law, Uniform Commercial Code, Model Penal Code*, ALI-ABA Periodicals, and the *Statement of Essential Human Rights* (a pioneering ALI project of the mid-1940s). **Bar Journals** Contains more than 70 state and local bar journals. Search by title, author, description, date, or across the full text of the articles.
